

Summer School 2018

Each year, the RTG organizes a week-long summer school. This year's Summer School was done in cooperation with the Priority Programme 1578. The summer school brings together leading international faculty and ambitious doctoral students. The summer school is open to our own doctoral students and interested students from other universities. The idea is to create a stimulating environment to discuss and start research. Admission is competitive. There is no tuition fee.

The first "Summer School -- Macroeconomics of Inequality" will be held from *June 25 – 29, 2018*. We are particularly pleased that *Per Krusell* (IIES Stockholm) and *Kjetil Storesletten* (University of Oslo) have agreed to be the lecturers of this year's first edition. The location is the Universitätsclub Bonn.

The morning of each day features lectures on the state of the art. The focus is the lecturers' choice. This includes empirical methods, such as the use of microeconomic data for macroeconomics, state-of-the-art theory, or numerical tools to quantitatively deal with inequality and heterogeneity in macroeconomics. The afternoon is reserved for student presentations. Lecturers and the group will provide feedback and discuss the ongoing research or research ideas.

The RTG's summer school provides a unique opportunity to learn from leading researchers in the field about their approach to the macroeconomics of inequality. The RTG 2281 Summer School has received generous financial support by the DFG's Priority Programme 1578 "Financial Market Imperfections and Macroeconomic Performance".
